Theoretical and empirical aspects must be taken into account. The empirical literature is to be evaluated with regard to data basis, methods and results

During the presentation, the results of the research and analysis are presented in a structured manner. At the end of the presentation, a concrete seminar topic-specific proposal for a reform of health insurance coverage based on the literature analysis in the paper is presented on a slide and defended in the seminar.
